SECTION 4 - FIRST-AID MEASURES

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures: All persons dealing with the clean-up should wear the appropriate chemically protective equipment. Keep people away from and upwind of spilt/leak. Restrict access to area until completion of clean-up. Refer to protective measures listed in sections 7 and 8.

Methods and material for containment and cleaning up: Do not allow material to contaminate ground water system. If necessary, dike well ahead of the spill to prevent runoff into drains, sewers, or any natural waterway or drinking supply. Ventilate the area. Prevent further leakage or spillage if safe to do so.
